20. Consider other items which may come before the Board; and

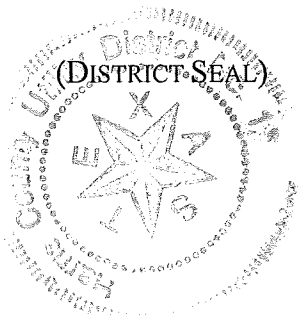
Closed Session
