15. Hear operator's report, discuss monthly delinquent list, hear any customer appeals, discuss maintenance report, and take any necessary action;

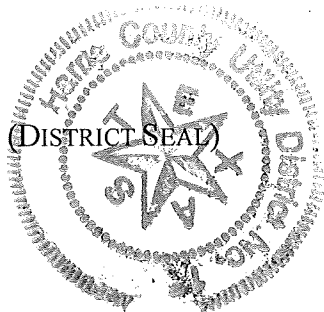
16. Review Operating Agreement and take any necessary action; Consider approval of amendment to Operating Agreement and take any necessary action;

Closed Session


