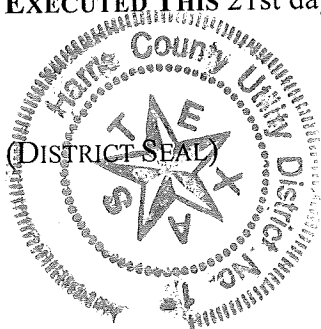
16. Review Engineering Agreement and take any necessary action;
