16. Hear operator's report, discuss monthly delinquent list, hear any customer appeals, discuss maintenance report, and take any necessary action;

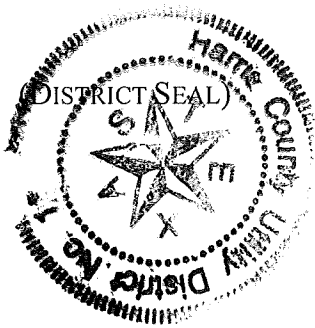
17. Hear report on detention pond maintenance, consider any proposals regarding same, and take any necessary action;
