15. Hear report on detention pond maintenance, consider any proposals regarding same, and take any necessary action;

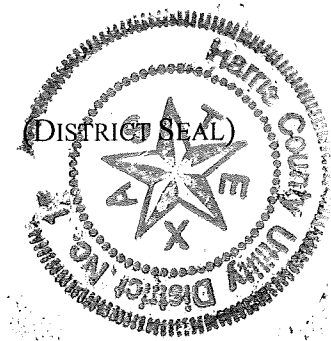

20. Authorize annual eminent domain filing and take any necessary action;

Closed Session


