17. Review Operator Agreement and take any necessary action;

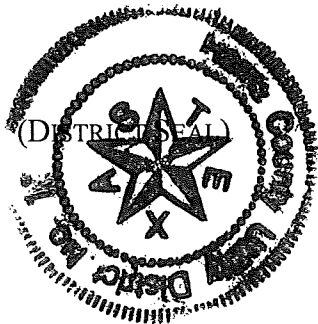
18. Hear report on detention pond maintenance, consider any proposals regarding same, and take any necessary action;
